#### INTRODUCTION

Historical novels serve as a portal through time, allowing readers to cross the boundaries of eras and learn new things. These literary works are not just records of events but linguistically rich texts, employing imagery, style, and language tools to transport readers into a different age.

Linguistic and stylistic analysis of literature works involves examining the language and stylistic means used in the text to uncover deep meaning of lexical and grammatical structures, their pragmatic and aesthetic effects. This analysis can encompass stylistic elements on different language levels.

When applied to historical fiction in English, the focus often shifts to identifying linguistic means of recreating the past, representing historical realities, and blending facts with fiction. In this work, we will consider contemporary historical novels by Philippa Gregory which exemplify historical accuracy and language abundance, describing the events in their finest detail and accuracy.

In the field of lingvo-stylistics, scholars employ various methodologies to analyze historical fiction. For example, Roman Jakobson's functional model of language, particularly the poetic function, Roland Barthes, introduced the concept of breaking down texts into codes, such as symbolic, cultural, and semantic, Seymour Chatman's distinction between story and discourse, in stylistics, Geoffrey Leech and Michael Short and other. These approaches help to uncover the ways in which language and style contribute to the representation of historical realities and the overall aesthetic experience of the text. Linguo-stylistic analysis of historical novels involves examining the language and style used by the author to convey the historical setting, characters, and themes.

The study of linguistic and stylistic tools in historical novels is a rich field, and many scholars explored this topic (Ferdinand de Saussure, Roman Jakobson, Roland Barthes, Jacques Derrida, Michel Foucault, Gérard Genette, Seymour Chatman). Linda Hutcheon examined narrative techniques, including stylistic elements, in historical and postmodern novels. Linda Hutcheon, Hayden White,

and Linda Woodbridge's research delve into the linguistic and stylistic features of historical narratives [24 p. 281-314, 59 p. 358-361].

One of E. Black's works "Once Upon a Time in a Tale" is devoted to this area of pragmatic stylistics. However, the stylistic aspect of the pragmatics of the text in this work, in our opinion, is not sufficiently covered. Therefore, we see the need for a clearer research of pragmatically oriented stylistic means in historical fiction.

**The relevance** of the work lies in the need for further study of lingvostylistic devices and their implementation in a historical fiction discourse, which will contribute to the interpretation of English-language historical fiction.

The aim of the paper is to study characteristic linguistic features and functions of stylistic devices in the novels by Philippa Gregory, and the stylistic and pragmatic effect they produce, as well as their interrelation.

To realise this aim, the following **tasks** were set:

- 1) to study peculiarities of English historical fiction;
- 2) to analyze lexical and grammatical features of Philippa Gregory`s novels;
- 3) to investigate stylistic peculiarities of Philippa Gregory`s novels and characteristics of her narration style.

The **object** of the study is the texts of two Philippa Gregory novels: "The White Queen" and "The Red Queen" of her Cousin's War series.

The **subject** of this research is lexical and grammatical means of these novels and functioning of various stylistic devices.

**The material of the study** is the novels "The White Queen", and "The Red Queen" by Philippa Gregory, a celebrated author in the realm of historical fiction.

**The methods** chosen for this research are all contributing to textual analysis: descriptive and contextual analysis, stylistic analysis, and structural-semantic analysis, discourse analysis.

The theoretical value of the work is determined by deepening of understanding historical fiction poetics, interpretating author's intentions and

pragmatic effect, analyzing correlation of different linguistic and stylistic means for creating the conceptual integrity of the text.

**The practical significance** is in the possibility of using results of the research in the practice of teaching English practical and theoretical disciplines, like English Stylistics, English Lexicology, Fiction Text Interpretation.

#### **CONCLUSIONS**

Historical fiction, which combines creative storytelling with historical authenticity, holds a special place in literature. The genre's hallmark is its capacity to take readers to a different time period through careful stylistic and linguistic decisions, which makes language a key component of its allure. With an emphasis on Philippa Gregory's works as models of contemporary historical fiction, this work explores the development of language in historical fiction, its lexical and stylistic elements, and the theoretical frameworks that guide its interpretation.

The dedication to authenticity is a key component of historical fiction. In order to create a sense of location and time, writers primarily use language to reconstruct the past. In order to transport readers to the past, classical historical fiction frequently uses idioms unique to the time period, formal speech patterns, and outdated terminology. Gregory and other modern writers, however, strike a balance between historical authenticity and readability by using language that is current and appealing to audiences while preserving a historical tone.

In historical fiction, linguistic and stylistic decisions play a crucial role in determining the emotional impact and authenticity of the story. Metaphors, similes, personifications, and symbolic imagery are only a few of the tools used by writers to create vivid situations and arouse strong emotional responses. Such strategies enhance thematic complexity and character development in Gregory's "The White Queen" and "The Red Queen".

Another characteristic of the genre is the use of emotive and descriptive language. Gregory uses symbolic imagery and sensory elements to immerse readers in the historical context of his books. The interior monologues and speech patterns of her characters add levels of complexity by reflecting their social situations, goals, and emotional challenges.

To evoke the past, historical fiction uses precise word choices. Gregory's works use archaisms and period-specific terminology, which anchor the story in its historical setting. Social hierarchies are frequently reflected in the dialogue, with

commoners using simpler, more direct speech and nobility using formal, decorous tones.

Gregory makes sure that the text is readable even though it uses antiquated terminology by steering clear of idioms that are too old or difficult to understand. As she has stated in interviews, she chose to employ contemporary speech patterns in order to maintain the historical period's spirit while making her characters relevant to readers today.

The study of language in historical fiction is enhanced by a number of analytical techniques. By analyzing syntax, figurative language, and theme structures, linguistic stylistic analysis reveals how these components support historical immersion. In order to examine how historical events are portrayed, narrative theory investigates storytelling approaches, making a distinction between diegesis (telling) and mimesis (showing). Semantic analysis reveals changes in meaning and symbolic uses of language, while discourse analysis explores how writing reflect or contradict social structures and cultural norms. Gregory employs these strategies in "The White Queen" and "The Red Queen", which emphasize the protagonists' internal issues and psychological complexity through character-driven storytelling. Her special focus on historical women's life experiences subverts conventional wisdom and provides new insights into historical occurrences.

Through the use of first-person narrative, Gregory establishes a deep relationship with her readers by letting them experience events through the protagonists' eyes. Her characters' voices, which are influenced by their unique linguistic and stylistic traits, capture their personalities, goals, and social settings, adding to the story's realism and emotional complexity.

By means of meticulous linguistic and stylistic examination, academics can reveal the complex interplay among language, narrative, and historical portrayal in historical fiction. This continuous investigation broadens our comprehension of the genre and strengthens our admiration for its capacity to bind us to the diversity of human history.
